### **MOONEE VALLEY RACECOURSE REDEVELOPMENT**

I also refer to your Council's request for interim heritage controls via Amendment C126 and permanent heritage controls via Amendment C124 to buildings and structures on the Moonee Valley Racecourse site.

The consideration of all matters, including those of heritage will be addressed by the Advisory Committee.

On balance, I believe intervention in heritage matters in advance of an Advisory Committee process would not result in the fair, orderly and sustainable consideration for development of the land and the authorisation of permanent heritage controls should be considered with the wider proposal for the racecourse site. The heritage matters will form part of the Advisory Committee's consideration.
